BACKGROUND REPORTS

There are a number of background reports commissioned which look at specific issues as part of an overall plan. These background reports were prepared by Cushing Terrell Architecture Inc. and include the following:

City Centre ARP Infrastructure Assessment Background Report #1 – August 2018

The purpose of this report is to assess the current City Centre infrastructure, evaluate the system capacities, service life and provide recommended upgrades and where required what the estimated costs could be for associated improvements/upgrades. These upgrades will increase the level of service of the City Centre for current and future development.

City of Spruce Grove City Centre Parking Study – June 2018

As part of the ARP study it was identified that a parking study has not been completed in the City Centre area. A parking study is sought to provide a baseline of current conditions. In the event that changes are made to parking through the CCARP, the City will be able to measure if the parking situation has improved.



City Centre ARP Land Use and Urban Form Background Report #2 – August 2018

The purpose of this document is to provide a framework and platform of directions and considerations upon which the Final ARP document will prepare specific policies structured in accordance to the Municipal Government Act (MGA) Section 635 as well as the Edmonton Metropolitan Regional Board
